



Virginia Personal Injury Lawyer Achieves National Board Certification

Additionally, to become a National Board-certified civil litigator, applicants must pass a written examination that tests their proficiency, knowledge and experience in civil law.

Less than 4 percent of all practicing lawyers in the U.S. are certified by an ABA-accredited or state-sponsored certification board, according to the NBLSC, which is an outgrowth of the [National Board of Trial Advocacy](#).

“The driving purpose of the National Board certification program is to better the quality of trial advocacy and help those in need of legal assistance to find experienced and highly qualified trial lawyers,” Cuthbert said. “I’m very honored by this distinction.”

Cuthbert is a graduate of Harvard College and the University of Virginia School of Law. He focuses his practice on representing victims of [motor vehicle accidents](#) and [medical malpractice](#) in personal injury and wrongful death lawsuits at both the trial and appellate levels. He also practices in the area of [Social Security disability law](#).

He is licensed to practice law in Virginia and North Carolina as well as the Fourth Circuit U.S. Court of Appeals and the U.S. Supreme Court.
